# DATA PROCESSING POLICY PURSUANT TO GDPR

Legal basis for data processing: the competitor's/participant's consent given pursuant to Section (1) a) of Article 6 of GDPR.

Purpose of data processing: staging a sport event (liaising with the competitor/participant)

Set of processed data: competitor's name, place and date of birth, address, e-mail address, telephone number, weight and height, clothing and sock size.

Period of data processing: data shall be processed until the end of the sport competition and for two years thereafter, and in the case of personal details that may serve as a basis for the enforcement of rights or claims the five-year statute of limitation shall apply pursuant to Section 6:22 (1) of the Civil Code. Furthermore, pursuant to the accounting rules, data shown on the invoice issued on the participation fee (name, address) shall be processed for eight years.

Method of data storage: paper based and electronic.

By signing this declaration and by accepting the General Terms and Conditions (GTC), the participant understands and accepts that for the purpose of popularising the programmes organised by SBI Promotion Kft. on the Company's website and Facebook page, image and sound recordings considered as general crowd image and sound recordings may be made at the competition. By signing this declaration and by accepting the GTC, the participant consents to the making and disclosure of such recordings in connection with this competition, and understands that the recordings shall be the property of the Company pursuant to the provisions of the Copyright Act. These recordings may include images/voices of the participants of the competition. No participant shall file any claim to the Company on this basis.
